Understanding of Services

- Updo- includes curls and all hair pinned up, buns, low buns, messy buns, full braids
- Special Occasion Style- includes curls and ½ up ½ down styles, 1/2 & side braids
- Shampoo and Style- includes wash and blow dry
- Addt'l \$10 for flat iron add on to shampoo and style
- False lashes are not included in makeup application (addt'l \$10-\$15)
- Parties booked with 4 or more services each and combined into one ticket (bride and bridesmaids) are eligible for 10% off. Services booked and paid for separately (bride and bridesmaids) are not eligible for 10% off unless the bridesmaids include 2 more services to final ticket (false lashes are not considered an additional service)

I, _____, hereby understand that I am fully responsible for above listed members of my bridal party. I understand that a down deposit is required and is nonrefundable if I cancel services. I understand that we are required to be present at the salon 30 minutes prior to our originally scheduled time. I understand that if my party is larger than 6 an 18% gratuity will be applied to each ticket. I understand that once accommodations are booked, rearranging dates and times may not be possible, but will be attempted by the bridal coordinator and I will be acknowledge if and when times have been rearranged. I agree to pay a \$50.00 travel fee for a 50 mile radius (round trip). I agree to provide the bridal coordinator with pictures of desired styles of hair and makeup to be properly accommodated by staff. I agree to inform the bridal coordinator of any and all changes in services, dates, times ect.
